The Synod Judicial Commission (SJC) will allow for live streaming of the trial proceedings in the week of March 7 (for Mr. Olivetti) into the Reformed Presbyterian Church of Lafayette (RPCL). For purposes of discretion and decorum there will be an appropriate delay in the live stream. There will be portions of the trial held in executive sessions; these will *not* be live-streamed.

Acceptable observers to the live stream must be active, resident, communicant members in good standing of either the RP Lafayette or the Immanuel RP congregation. Attendees must sign up in advance. Any and all others are not allowed in the viewing area during the trial proceedings. The deadline for signup is 6 pm on March 6, but please do so earlier if at all possible. Members of Immanuel RPC may need to show identification in order to be admitted. The moderator (or clerk) of the congregation of which the individual is a member will be responsible to transmit the list of names to the Clerk of the SJC no later than the evening of March 6. The SJC will then furnish for each day the roster to be signed by admitted persons to the church building for attendance at the live stream.

The Commission is requiring *all* observers – even at the immediate trial venue and the chosen Synod observers – to sign its Terms & Responsibilities sheet each day upon entrance. Please arrive early enough to sign in if you wish to be present when the trial starts. The trial will start at the appointed time. The Commission's moderator first will confirm that only registered people are present and they have signed the Terms & Responsibilities. (The appointed bailiffs at RPCL will confirm registered persons who either arrive late, or must leave, upon their entrance or exit.)
